125.1/18 It was agreed that the minutes of the meeting dated 20th February 2019 be accepted as a true and accurate record of the meeting. Proposed by Cllr H Field and seconded by Cllr J Savin.

127.1/18 The first applicant, Tom Grundy talked through his covering letter.

128/18 Police Report

128.1/18 It was requested that the clerk contact the PCSO's to advise how the current report has been improved, the quality of the reporting and the information relayed, proposed by Cllr h Field and seconded by Cllr S Edwards.

129/18 Minera Community Council Chairman Report, appended to the minutes.

129.1/18 The chair talked through his report.

129.2/18 The tree fallen on the footpath, Sion Roberts has been advised, it is up to the landowner that the tree is on, to resolve. WCBC will contact landowner to sort.

129.3/18 The sink hole on Allt Y Eisteffod still needs to be resolved.

130/18 County Borough Council Report

130.1/18 Cllr D Kelly has challenged the highways department about the dressing on the Old Road, the surface dressing will be completed from March to April when better weather and conditions will let it work better. It is to be resurfaced from the Moors to the Village Bakery.

130.2/18 Discussions about pot holes, across wards and across Wrexham. An assessment is completed straight away and if repairs are required, they will be done asap. If they are not deemed to be an issue they will not treat.

130.3/18 Cllr D Kelly advised that there were issues with the LED lights which have been installed in the Brymbo ward, they have caused some complaints about the light dispersal, the community council wish the lighting committee to look into further, to ensure the correct dispersal is completed correctly for the different areas.

131/18 School Governors Report

131.1/18 All of the comments made to Council at its last meeting still apply. Much of the work of the school is still concentrated on extending the high-quality teaching observable in some classrooms and embedding it in all classrooms.

131.2/18 The school has completed the exercise of seeking parental evaluation of its work and their child's/children's educational experience. Again, results have been most encouraging. In the vast majority of cases there is unconditional praise for the work of the school, for the enjoyment it gives the pupils and for the learning benefits they derive.

131.3/18 This exercise has been conducted using social media which has produced a greater response from parents than in previous years. The same technology continues to assist the school in communicating with parents about future events and requirements-in short, about what's going on.

131.4/18 The financial profile of the school is entirely sound too. A modest surplus should be achieved at the end of the financial year to cushion the effects of expected increases in costs next year-a position which will be the envy of many a school in the area. Grateful acknowledgement has to be recorded for the financial contribution from the Diocesan Education Board of the Church in Wales in helping to achieve this financial position.

131.5/18 The number of pupils on roll is increasing too-further encouragement to Headteacher Spencer Williams and his staff- who assuredly deserve the community's thanks for all their hard work.
