15.1/18 Dave Kelly advised the funding for PCSO is being reduced by the WCBC, there will be a reduction in pcso's in the next twelve months. The Pcso's are being allocated to where the most crime is perceived to be happening. Coedpoeth is an operational station so we have pcso's stationed there but will only deploy them to areas with issues. Wrexham are the only authority who actually fund additional PCSO's.
